Waiver of Liability

Recognizing the dangers associated with sailing and racing and in consideration of the opportunity to participate in this regatta, I, for myself and my heirs, successors, representatives, and assigns and for my crew and their heirs, successors, representatives, and assigns, **waive any and all claims of any sort** that I may have or my crew may have against the Beverly Yacht Club, the J/105 Class Association, J/105 Fleet 14, the organizers of this regatta, the Race Committee, sponsors, and their employees, agents, volunteers, officers, directors, and committees. I agree also that this waiver is to be construed broadly and inclusively under the laws of the Commonwealth of Massachusetts and the maritime laws of the United States.

I fully understand and agree that the decision to race and the safety of my sailboat and crew is the sole responsibility of the owner (or charterer). This responsibility extends to the safety and integrity of the boat, the decision to sail and race in given conditions, and the competence of the crew to sail and race in given conditions.

I accept the terms and provisions of the Notice of Race, the Sailing Instructions, and the Waiver of Liability. I will make a copy of each available to each member of my crew.

I certify that I and all members of my crew are 18 years of age or older and that I have authority for myself and on behalf of my crew to execute this Entry and Registration Agreement, including the Waiver of Liability. [NOTE: in the event that any crew member is under age 18, a separate waiver of liability must be executed on his or her behalf by parent or guardian.]

I agree to bound by the current *Racing Rules of Sailing* and the 2004 J/105 Association Class Rules (Level A National Event) that govern this event.
